

CLASS NUMBER AND NAME: LGN370A DISCOVERY I

TOTAL CLOCK HOURS/UNITS: 24 Hours/2 Units

PREREQUISITES: LGN231F - Estate Planning and Probate

CLASS DESCRIPTION: This course concentrates on discovery and investigation in civil litigation.

Students will review case scenarios and recommend courses of discovery procedures to be taken. Students will prepare and respond to numerous discovery documents including interrogatories and requests for production of documents. Students will also review and summarize depositions of parties. The course will provide the student with an understanding of the

rules for California discovery procedures.

CLASS OBJECTIVES: This class is designed to provide the student with the skills and knowledge

necessary to prepare numerous discovery documents, including interrogatories and requests for production of documents, and to summarize depositions. Students will learn to conduct investigative research that will enable them to find evidence that can be used at trial.

This is an approximate schedule and is subject to change at the instructor's discretion. The student is responsible for any missed

information and handouts due to absences. Homework includes familiarizing yourself to the Calendar and Syllabus, textbook reading assignments, and study guide homework plus diagrams, flashcards, and practice tests all when appropriate to augment learning. The time spent in preparation for or reflection on course lecture will approximate two hours outside of class for each lecture credit hour utilized by the instructor in delivery of the materials and ½ hour outside of class for each hour of

structured lab time.

CLASS FORMAT OVERVIEW: The class will consist of lecture, class discussion, assignment overview,

and lab time. Students are expected to work diligently on their

assignments, including reading all materials outside of class as well as in

class. Class participation is required.

ATTENDANCE: It is critical to the student's success to attend class every day. The

student's presence for the entire hour is an important demonstration of the concept of professional demeanor and shows respect for the class. Therefore, students will only be marked present when they arrive on time and remain for the entire class session. A student must be present for a minimum of 80 percent of the class, or she or he will be asked to leave the class and will receive a failing grade in

the class.

This includes understanding and properly using objections based on California Evidence Code and California Code of Civil Procedure as well as California Rules of Court. Properly draft responses to special interrogatories, including proof of service;
- 2. Analyze case information and formulate special interrogatories. This includes understanding any and all objections that may be used by the responding party and formulating interrogatories that will escape objections and be worthy of responses. Properly draft responses to special interrogatories, including proof of service;
- 3. Review and understand deposition transcripts. Properly summarize deposition transcripts. Understand statutes pertaining to depositions;
- 4. Understand California evidentiary rules, scope of discovery disclosures, and miscellaneous discovery procedures. Students will learn to conduct investigative research that will enable them to find evidence that can be used at trial; and
- 5. Organize and index discovery documents.
