<b>CLINIC DESCRIPTION</b> (from catalog):	This clinic provides students working with self-represented litigants. All cases are in the areas of family law. SHAC offers free legal services to persons who have a related case in Sonoma County. Students will meet individually with parties and assist them with filing the complex court documents for divorce, paternity, custody, support. Students will learn Martin Dean Essential Forms, drafting of pleadings and local court practices, and communication skills with individuals going through emotional family law issues. A supervising attorney will oversee the work.

<b>FORMAT OVERVIEW / METHOD OF INSTRUCTION:</b> (Description of how the clinic will be taught, including breakdown of lecture, practicum, etc.)	Students will interact with clients, and direct clients to legal and non-legal resources related to their case or issues. The students will draft legal documents under supervision of a practicing attorney. Clinic's Supervising Attorney will supervise all work done in the SHAC Clinic. Course material will be presented in a lecture-discussion method format.

Attend 10 clinics AND 3 training sessions;</li> <li>2. A minimum of 80% attendance is required.</li> </ol> <p>Grade in this clinic is based 100% on participation and attendance.</p>
<b>ATTENDANCE:</b>	Regular and punctual attendance is essential for the successful completion of law school. Students should plan to attend every class. Students must attend a <b>minimum of 80% (3 training sessions and 10 clinics)</b> of the class sessions during each semester to be eligible to pass this class. Roll will be taken at each class.
