Superscript note explanations:

- 1 Legal Research & Writing (JUNE) begins 6/6/16-ends 8/8/16; Introduction to Law (JUNE) begins 6/7/16 - ends 8/9/16.
- 2 Adv. Legal Research is limited to 14 students with priority given to 3rd- and 4th-year students and meets for 10 sessions.
- 3 Law Study & Exams - session started 2/4/16 and ends 4/7/16, then resumes 5/5/16 and ends 6/2/16
- 4 Moot Court limited to 16 students, priority given to 3rd- and 4th-year students.
- 5 Disability Law Clinic is limited to 6 students. (Option to take for 1 or 2 units also.)
- 6 SHAC is limited to 8 students. (First three training class sessions meet 6:00 – 9:00 P.M.)
- 7 Advanced Legal Writing is limited to 20 students.
- 8 Elder Law and Small Claims Advisory Clinics are limited to 8 students.
- 9 Clinical Education is available to 3rd- and 4th-year students only.
- 10 Legal Aid Clinic - (option to take for 2 or 3 units)
- 11 Professional Responsibility is limited to 25 students and requires completion of 2nd year classes.
