<b>COURSE DESCRIPTION:</b>	Covers prevailing common law and statutory torts, defenses, and the jurisprudential basis in public policy of these civil actions. General topics include intentional wrongs to person and property; negligence; duty of persons in control of property; tort liability arising from contractual relationships; liability for defective products; liability without fault; deceit; defamation; malicious prosecution; interference with economic relations, and tort alternatives.	
<b>COURSE OBJECTIVES / ANTICIPATED LEARNING OUTCOMES:</b>	<p>Students will learn the essential elements for the various torts as well as their interrelationships. Fact patterns will be analyzed to ascertain the different theories of tort liability which may be applied. Students will be expected to demonstrate their knowledge through classroom case briefing, discussion, and performance on essay and multiple choice exams.</p> <p>While the course includes consideration of the evolution of tort law and how tort law fits into the larger social fabric; the principle goal of the course is to cause students to develop and demonstrate a level of competency in this core subject and in legal analysis that will enable them to qualify to practice law.</p>	

<b>FORMAT OVERVIEW / METHOD OF INSTRUCTION</b>	Course material will be presented in a lecture-discussion format. Students will be expected to participate in class discussions by sufficient review of the text and briefing of cases.
<b>EXAMS:</b>	<p>The grade will be comprised of the results of a three hour midterm exam (25% of final grade) and a three hour final exam (75% of final grade).</p> <p>Two essay questions and a series of multi-state/multiple choice questions will be given for both the midterm and final exams. For the essay questions, students will be expected to identify the legal issues raised in the fact patterns, apply the appropriate rules of law, and arrive at a well reasoned conclusion.</p> <p>For the multi-state/multiple choice questions, students will be expected to choose the best of alternative answers, according to generally accepted common law views.</p> <p>General Policies: Exams begin promptly at 6 p.m. All students must take examinations as scheduled. It is recognized that in special circumstances and due to emergencies, it may be necessary to schedule delayed examinations. An emergency is defined as a serious illness or injury to the student or a member of his or her immediate family. Special Circumstances are defined as other situations that, in the opinion of the Dean, are sufficient to warrant delay in taking examinations. <b>Any student taking delayed examinations <i>must have the prior written approval of the Dean.</i></b> No examination may be taken <i>prior</i> to the day of the regularly scheduled examination. If delayed examinations are approved by the Dean, <u>a fee of \$75 will be charged for each such exam taken.</u> Failure to complete an exam is not sufficient reason for a late or retake exam.</p>
